Tuition is charged for ALL contracted days, regardless of attendance. Monthly payments are due prior to the 1st of the month beginning September 1, 2022. Service may be terminated if payment is not received in advance of service.</p>

<b>Escrow Policy</b>		
An initial deposit, equal to one month tuition, must be paid in full at time of enrollment. The deposit will be held in escrow throughout the course of service. A withdrawal notice of one month must be given for the escrow to be returned.		
<b>Payment</b>		
Payment is due in advance of service, on the 1 <sup>st</sup> of each month from September to June. The fee will be charged regardless of child's attendance or whether the center is open or closed (scheduled or emergency closing). Payments are to be made on brightwheel. A registration code will be sent to set up accounts and payment information. <b>A convenience fee of 2.9% will be added to all credit or debit card payments.</b> There is no fee when adding bank account information for purposes of paying via direct electronic funds transfer (EFT).		
<b>Delinquent Fees:</b>	A late fee of \$25.00 will be added to any account with a balance on the 10 <sup>th</sup> of each month. Failure to adhere to tuition policies and schedule may result in termination of service.	
<b>Fee Increase:</b>	Wonderspring reserves the right to increase fees at any time. A 30-day advance notice will be given. Families that pay the year in advance are still subject to any rate increase.
